## **SWAINS ISLAND DXPEDITION POSTPONED**

The W8S DXpedition to Swains Island in the Pacific, set to take place in mid-March, has been postponed until September as a result of travel restrictions imposed on individuals entering American Samoa, stemming from the recent coronavirus outbreak. The Department of Health allows non-residents to enter American Samoa only via Hawaii after a 14-day mandatory quarantine, and the DXpedition was unable to accommodate that requirement.

"Everything is prepared for our DXpedition, and we are eager to go, but unfortunately the coronavirus outbreak is out of our control," the DXpedition team said in announcing the delay. "Although this is a disappointment for everyone, the W8S DXpedition is not cancelled, just postponed for later this year."

The DXpedition said it would alert the DX community as soon as it has new firm dates for the trip.

## **CLARIFICATION ON INDIANA HB 1070**

As sent by ARRL Indiana Section Manager, Jimmy Merry, KC9RPX, following is some clarification regarding the operation of mobile amateur radio gear.

HB 1070 addresses the use of a "telecommunications device" which is defined in IC 9-13-2-177.3 thusly:

(a) "Telecommunications device", for purposes of IC 9-21-8, IC 9-25-4-7, IC 9-24-11-3.3 (before its repeal), and IC 9-24-11-3.7, means an electronic or digital telecommunications device. The term includes a:

- (1) wireless telephone;
- (2) personal digital assistant;
- (3) pager; or
- (4) text messaging device.

**(b) The term does not include:**

- (1) amateur radio equipment that is being operated by a person licensed as an amateur radio operator by the Federal Communications Commission under 47 CFR Part 97; or**
- (2) a communications system installed in a commercial motor vehicle weighing more than ten thousand (10,000) pounds.**
